

Cornish Campers Ltd. Rental Agreement

1) Your Contract With Us

- a. When you sign this Rental Agreement you accept the conditions set out here in (this document will be presented to you before your departure and must be signed before you depart).
- b. Please read this agreement carefully. If there is anything you do not understand or do not agree with, please ask a member of Cornish Campers Ltd.

2) Rental Period

- a. You will have the vehicle for the rental period shown at the end of this agreement. The rental period will be shown with time and date of departure and time and date of return of the vehicle. If you do not bring the vehicle back on time you are breaking the conditions of this agreement. We reserve the right to charge you a late return fee if the vehicle is not returned by the time stated at the end of this agreement.

3) Hirer's Obligations

You are responsible for:

- a. Driving the vehicle in a cautious, prudent and normal manner.
- b. Any damage to the vehicle, any of its parts or any of the equipment provided with the van.
- c. For any loss or damage to additional equipment hired at the time of rental, including but not limited to equipment hired at the time of rental.
- d. Ensuring that you look after the vehicle and the keys to the vehicle. You must always lock the vehicle when not using it and use any security device supplied with the vehicle.
- e. Ensuring you always use the correct fuel.
- f. The payment of reasonable costs if we have to pay extra costs to return the vehicle to its condition when the pre-rental inspection was carried out (for example, if extra valeting time or special material or equipment is needed to restore the vehicle to its pre-rental condition) or if the vehicle has been damaged internally or externally whilst in your care.
- g. Ensuring you do not sell, rent or dispose of the vehicle.
- h. Ensuring no one works on the vehicle without our permission.
- i. Ensuring you contact us as soon as possible and within a maximum of 12hrs of having an accident and/or any fault with the vehicle.
- j. For returning the vehicle to the place we agreed on your departure on time and on the date specified at the end of this agreement.

You or any other driver named at the end of this document must not:

- a. Allow the vehicle to be driven by anyone other than yourself or the named driver.
- b. Use the vehicle for hire or reward.
- c. Use the vehicle for any illegal purpose.
- d. Use the vehicle in a manner, which could cause damage.
- e. Use the vehicle to carry more persons than are permitted by any relevant authority or detailed in this agreement.
- f. Use the vehicle while under the influence of alcohol or drugs.
- g. Drive the vehicle outside Devon and Cornwall, unless we have given you written permission.
- h. Use the vehicle or allow it to be used off road or on roads unsuitable for the vehicle.

4) Our obligations

- a. We have maintained the vehicle to a high standard to ensure to the best of our ability that the vehicle is roadworthy and suitable for renting at the start of the rental period. We will show you how to use the vehicle, answer any questions you have before you depart and go through this Agreement with you before you are expected to sign it.
- b. In the event that your vehicle is unavailable for reasons out of our control, such as the vehicle has been involved in an accident prior to your agreed Vehicle collection time, we will endeavour to provide a replacement vehicle. If a replacement vehicle is unavailable then we will refund all monies including your initial booking fee of £150.

5) Road Restrictions

- a. All Vehicles may only be driven on sealed / bitumen roads.
- b. I acknowledge that Cornish Campers Ltd. reserves the right at any time, at its sole discretion, to restrict vehicle movements in certain areas due to adverse road or weather conditions or any other reasonable cause.

6) Insurance and damage protection

I fully understand that:

- a. The Vehicle is insured for damage and the property of a third party; The excess may be reduced or removed, in most circumstances, by taking out a Collision Damage Waiver Fee (CDW). A CDW fee is available for all vehicles at an extra daily cost of £10 (or £70 per week). For short breaks there is a minimum payment of £50. This extra fee will eliminate the £500 excess fee due to be paid by you in the event of an accident. There is also an option to pay £5 per day (£35 per week) or £25 for short breaks, which would reduce the excess fee to be paid by you in the event of a collision to £250.
- b. I will have to pay an excess of up to £500 for any damage. The CDW will eliminate or half the £500 excess fee to be paid by you in the event of a collision.
- c. I will not have any insurance cover and I will be responsible for the total cost of any damage if I breach any of the terms of this agreement and/or the Terms and Conditions.

7) Charges

You are responsible for paying Cornish Campers Ltd. the following charges:

- a. All rental and any other charges calculated in accordance with this agreement.
- b. A late return fee of £25 per hour if the vehicle is not returned on time (we expect the hirer to return the vehicle on time as vehicles will require maintenance and inventory checks and need to be cleaned before being rented out again that same day).
- c. The nominated valeting fee of £100 if the camper is not returned with the interior in a clean condition.
- d. The nominated cancellation fee in the event of cancellation of this agreement prior to the hire.
- e. The cost of any damage to the camper or the property of any third party, subject to the insurance or CDW cover.
- f. The Collision Damage Waiver fee, if applicable.
- g. All fines, court costs and intended prosecutions for parking, traffic or other offences (including any costs which arise if the vehicle is clamped). You must pay the appropriate authority any fines and costs if and when the authority demands payment.
- h. A re-fuelling service charge of £15 plus the fuel required to fill the tank if you have used and not replaced, the quantity of fuel that we supplied at the start of the original rental.
- i. The cost to recover a Vehicle, which has become bogged (this cost will vary depending on severity of the accident and the location of the vehicle).
- j. All charges and expenses payable by me under this Agreement are due on demand by Cornish Campers Ltd. If I do not pay all charges when due, I agree to pay a late charge of 1.5% per month on the outstanding balance and any collection costs incurred by Cornish Campers Ltd., including reasonable legal fees. When the Customer comprises of more than one person, each person is liable jointly and severally for all obligations of the customer pursuant to this Agreement.

8) Accidents

In the event of an accident and or loss or damage arising out of the use of the Vehicle you must:

- a. Notify Cornish Campers Ltd. within 12hrs of the accident.
- b. Obtain the names and addresses of third parties and any witnesses and report the event to the police.
- c. Obtain the insurance details of third parties, third party vehicle registration and where possible take photos of the incident.
- d. Make no admission of liability to other parties, settlement offer or other like offer.
- e. Assist Cornish Campers Ltd. in handling any claim arising from any event, including providing all relevant information and attending Court to give evidence if required.
- f. Acknowledge that the excess or other amount due by me in respect of any damage arising from an accident, loss or damage is payable at the time of reporting the event and not at the completion of the rental period.

9) Maintenance

- a. I understand that I should take all reasonable steps to properly maintain the Vehicle, including oil checks, water and batteries.

- b. I acknowledge that Cornish Campers Ltd. will reimburse me for expenditure up to UK£100.00 reasonably incurred in rectifying any mechanical failure to the drive train and engine of the Vehicle (not including the water system, refrigerator, heating, audio and DVD equipment) provided that I produce the relevant receipts, have received the prior consent of Cornish Campers Ltd. and the damage is not due to my fault or my breach of this Agreement.
- c. Subject to the terms of this agreement, I will pay for the cost of repairing or replacing tyres damaged during the Rental Period provided that Cornish Campers Ltd. will reimburse me for expenditure reasonably incurred if I produce relevant receipts, the tyre is defective and is returned by me to Cornish Campers Ltd. for inspection and the manufacturer accepts liability under his warranty.
- d. I will be liable for any costs associated with the incorrect use of fuel (fuel being diesel or petrol).

10) Collection/Delivery & Return of the Vehicle

- a. I will acknowledge receipt of the Vehicle in a clean condition and in sound working order in accordance with the Departure Checklist and with a full fuel tank (the Rental Agreement will be produced for signature prior to departure).
- b. I will adhere to the collection and/or delivery and return times shown at the end of this Agreement (the vehicle will be available from 16:00 on the day of collection (the day your hire commences) and must be returned by 10:00 on your return day (the day your hire ceases).
- c. I will return the vehicle in a clean condition with a full tank of fuel by 10:00 on the final day of hire.
- d. I acknowledge that Cornish Campers Ltd. will not refund to me any monies and are under no obligation to provide a replacement vehicle if the Vehicle is returned or I cease to have the use of the Vehicle prior to the return date for any reason including accident, weather and theft.

The final page of this document needs to be completed and signed by both parties (renter and hirer) on collection of the vehicle.
